## 1. GADN News

---

### **Women's Rights in the Current International Aid Environment: Challenges and Opportunities**

On Thursday 7 April, Rosalind Eyben drew on her research (**Pathways of Women's Empowerment**) for GADN's afternoon seminar on Women's Rights in the Current International Aid Environment. Rosalind's presentation was partly based on a number of consultancies for the **OECD Development Assistance Committee** and partly based on her own opinions. Earlier this year Rosalind wrote a piece for **Contestations**, where she concluded with a call to action: "Don't just leave this to monitoring and evaluation experts to worry about. It requires a massive push back from women's rights activists to make the space for social transformation that donor action risks shrinking." During the seminar Rosalind explored the reality of the environment in which we are collectively working and trying to promote women's rights, a reality which is not going to go away. As part of this Rosalind looked at the opportunities and challenges this reality presents, and asked: How should we respond?

### **Save the date: Monday 4 July – Beyond Women and Girls' Vulnerability: a debate on gender, climate change and disaster risk reduction**

Join us at **IDS in Brighton** on **Monday 4 July** for the launch of publications on gender, climate change and DRR by **IDS, Plan UK** and **Oxfam** as we discuss alternatives to casting women and girls as always vulnerable to the effects of climate change and disasters. Alternatively, do global systems relating to climate change and disaster risk reduction serve the people who are the frontline of climate change – do they remedy or transform power? We are pleased to announce that the key note speakers will be **Lorena Aguilar, Ulrike Röhr** and **Irene Dankelman**. More information will be available soon.

### **Updates from GADN Working Groups**

#### **Violence Against Women and Girls**

In February, the VAWG working group provided Lynne Featherstone, Ministerial Champion on International Violence against Women, with a briefing on recommended priority areas of focus for the Minister, namely Sexual Violence in Conflict as a Security Issue, and Violence against Women and Political Participation. In April, the working group followed up this briefing with recommended country visits for Lynne Featherstone in line with these priority issues. On Sexual Violence in Conflict as a Security Issue, GADN recommended visiting the DRC, Ivory Coast or Liberia, and on Violence against Women and Political Participation, visits to Afghanistan, Egypt, Liberia or Zimbabwe were recommended. The group outlined the importance of the Minister meeting with women's organisations and women's rights activists in the places she visits. The group assured the Minister that whichever countries she decides to visit, members of the network will be happy to facilitate meetings with relevant partners in those countries.

The toolkit showcases examples of women's organisations in Latin America and the U.K. that are practically implementing intersectionality in their work on Violence against Women and Girls (VAWG). As a resource it gives continuity to the campaign process and political impact to a new perspective for the creation of public policy with a holistic and inclusive focus in order to eradicate poverty and VAWG in Latin America.

- **ActionAid** is recruiting:

1) A **Policy Adviser** to support ActionAid's work by undertaking rigorous policy analysis, research and advocacy on aid, economic justice and development finance issues, looking both at aid and at how developing countries can exit from aid. The Policy Adviser will be involved in public debate, communicating our work through writing, media, social networks and public speaking. Deadline for application submission is **Monday 16<sup>th</sup> May 2011**.

2) **Policy Adviser (maternity cover)** to support ActionAid's strategic objectives by looking into how the private sector affects people living in poverty. The role will involve undertaking rigorous policy analysis and research, and propose directions for our advocacy work on business and human rights, identifying instances where the private sector could and does play a positive role in development, highlighting where engagement advocacy could be an effective approach to achieving change. It will also identify instances of corporate abuse by UK and other companies and areas where the private sector poses a significant barrier to our achieving strategic objectives. Deadline for application submission is **Tuesday 24<sup>th</sup> May 2011**.

3) **Director of Fundraising** to lead the Fundraising function setting the strategic direction and agenda for Fundraising in the UK as well as ensuring it drives delivery of our objectives. The Director will have overall responsibility for providing inspirational leadership to a team of 70 staff across a variety of fundraising areas including Philanthropy and Partnerships, Programme Funding, Supporter Marketing, Supporter Care and Major Gifts. This will involve developing campaigns, delivering effective systems to manage donor relations, ensuring value for money and setting best practice fundraising standards. **New WIDE Publication - “The Other Financial Crisis: Poor Women, Small Credits, Big Businesses” by Christa Wichterich.**

*“India is in the midst of a financial crisis that shows striking similarities to the US subprime crisis, both in its origins and the rescue strategies used. Just as the cheap mortgage granted to low-income households in the USA, the microcredits given to poor women in rural areas worked out as financialisation of everyday life and integration of the women into the global financial market with its return-based logic. This jeopardised the social processes and the very objectives at the heart of the initial non-profit microfinance model. The growth of this sector led to an over-supply of microcredits in villages and in turn to the over-indebtedness of women, the collapse of repayments and a capital shortage of the microfinance institutions. What seems at first sight to be a specifically Indian crisis results in fact from the market rationale of growth, overheating, and crisis.” (Wichterich 2: 2011)*

- **WIDE calls for proposals for the AWID Forum 2012 - Transforming economic power to advance women’s rights and justice**

The AWID Forum 2012 will be held on **19-22 April 2012 in Istanbul, Turkey**. The 2012 AWID Forum aims to explore how economic power is impacting on women and the planet, and to facilitate connections among the very diverse groups working on these issues from both human rights and justice approaches to contribute to stronger, more effective strategies to advance women's rights and justice.

You have an opportunity to contribute to shaping the conversation and the strategies at the 2012 AWID Forum by submitting a proposal to organise a session.

AWID has selected 10 themes which reflect some of the core dimensions and manifestations of economic power. They are also crucial areas in which economic power impacts on and intersects with a diverse range of women's rights issues. Since the themes are interrelated, you will have the option, when submitting your session proposal, to indicate the "primary theme" to which your session proposal relates and whether your session is closely linked to a second theme as well. - **The Joan B. Kroc Institute for Peace & Justice (IPJ) at the University of San Diego in California is currently accepting applications for its Women PeaceMakers Program (WPM)**

The WPM program is designed for leaders from conflict-affected countries around the world who are transforming conflict and assuring gender-inclusion in post conflict recovery through in human rights advocacy and peace building efforts they lead. These are women whose stories and best practices will be shared internationally; they are women who will have a respite from the frontlines work they do.

Four Women PeaceMakers are selected each year to spend two months in residence at the Institute. They will receive a small stipend while having their unique peacemaking stories documented, through both film and narratives that will be available to inspire others around the world. Women PeaceMakers in residence will have the opportunity to engage with the community through a series of public panels and to meet with other activists and leaders involved in human rights, political action and peacemaking efforts.

Four Peace Writers are selected each year to document the stories of Women PeaceMakers for publication. Writers will interview the Women and engage in extensive research to become familiar with the histories of their conflicts and peacemaking efforts.

Residency dates are **10 September – 5 November 2011 for *Peace Makers*** and **6 September – 23 November 2011 for *Peace Writers***.

- **The NEPAD/Spanish Fund** has announced its second call for proposals. The Fund will provide grants to projects in sub-Saharan Africa aimed at enhancing the empowerment of women and gender equality. The call for proposals will support initiatives under the following themes: improving women's economic empowerment, civil society strengthening and institutional strengthening.

Information on eligibility and guidelines for applicants is available on the NEPAD Agency **website**.

There is a specific proposal template/format, which must be adhered to when completing the application.

The deadline for submission of proposals is **15th May 2011 at midnight GMT**.

- **Live the Promise: HIV and AIDS Campaign Action Alert**

This week, negotiations have started in New York on a document that will encapsulate the outcome of the 2011 UN Review on AIDS. This review aims to assess progress made in the global HIV response over the last ten years. In particular, governments are analyzing the implementation of commitments made in the UN Declarations in 2001 and 2006. One such commitment promised to deliver universal

access to HIV prevention, treatment, care and support by 2010. But this has not yet become a reality.

The new outcome document is expected to be formally adopted by governments at a High-Level Meeting in New York on 8-10 June.

  2. **Hold a Parallel Prayer Breakfast in June.** On 10 June, EAA members and partners are holding an Interfaith Prayer Breakfast in New York. The event will promote leadership and accountability for the implementation of the new outcome document. In particular, it will bring together leaders from different sectors, including religious leaders, political leaders, business leaders, people living with HIV and representatives of key population groups, with a view to forging new partnerships for strengthened collaboration in the response to HIV. - **A policy of empowerment: the politics of gender and technology in international microbicides research, Wednesday 18 May 12.45 – 2 p.m Jerry Morris A (Room G13), Tavistock Place, London WC1H 9SH.**

**Guest Speaker: Dr Catherine Montgomery, ESRC Postdoctoral Research Fellow, Sociology Department, University of York**

This seminar provides an account of the relations between science, society and technology in the development of the international microbicides research agenda. Vaginal microbicides are pharmaceutical products in development designed to reduce the sexual transmission of HIV in women. They are commonly known as a 'woman-controlled technology' and tool for women's empowerment, and form part of a burgeoning field of clinical research into new biotechnologies for HIV prevention. Using theoretical insights from science and technology studies (STS) and empirical data from key actors involved in the research process, this work sheds light on the global politics of prevention and the strategic use of gender and empowerment discourses to obtain research funding. This seminar explores the social production and perpetuation of socio-scientific discourses of gender and HIV, and discusses the implications of this for new prevention technologies in the context of global product development partnerships.
