- **Call for Research Pre-Proposals: Gender and Citizenship in the Information Society-An Asia-wide Research Programme**

IT for Change, with support from IDRC, is launching an Asia-Wide Research Programme, 'Gender and Citizenship in the Information Society'. This initiative proposes to explore how the concept of citizenship may be useful to study the gendered context of the emerging techno-social paradigm. It aims to build a theoretical framework and generate policy directions from the standpoint of marginalised women in the region. The Programme will award about 8 grants of up to 25,000 USD each, for one year of primary research. The deadline to send the Pre-Proposal is **April 28th, 2010**. - **Calls for UNIFEM Proposals: "Campaigns to end violence against women and girls"; "Working with the security sector to end violence against women and girls"; and "Working with the justice sector to end violence against women and girls"**

The knowledge asset on "Campaigns to End Violence Against Women and Girls" (distilled programming guidance, programme examples and case studies) should be tailored to provide practical guidance for the development and implementation of campaigns that address gender-based violence specifically. The focus of the module "Working with the Security Sector to End Violence against Women and Girls" is to provide 'state-of-the-art' how-to guidance on working with the security sector to prevent and respond to violence against women and girls. The focus of the module "Working with the Justice Sector to End Violence against Women and Girls" is to provide 'state-of-the-art' how-to guidance on working with the justice sector (in particular, the informal justice sector) to implement legislation and human rights standards related to ending violence against women and girls. Deadline for proposals has been extended to **April 23, 2010** and for the knowledge asset to **April 27, 2010**. - **Call for Papers: Gender and Economics in Muslim Communities**

Over the past decade, there has been an increasing recognition of the importance of understanding economic conditions in a broad range of contemporary Muslim societies. However, large gaps remain in our knowledge of the links between gender, economic well-

being, and the varying influences of religion due to gender-blind analyses and unexplored assumptions and generalizations regarding Muslim women's experiences. Deadline for paper submissions: **August 15, 2010**.

This special issue, planned for online publication in 2013 and print in 2014, aims to provide a forum for rethinking the study of socioeconomic policies and processes that impinge on women's and men's lives in Muslim families, communities, and countries around the world. Sought are contributions that interrogate the prevailing discourses and explore new insights into women's economic well-being in Muslim communities. Of special interest are submissions that pay attention to women's agency and voice and the intersections between religion, gender, class, and ethnicity in the analysis of outcomes. Submissions that rely on a variety of methodologies and research methods, including interpretive and quantitative methodologies (such as country-level or cross-country analyses), are welcome. *Feminist Economics* very much encourages submissions from the Global South and Central/Eastern Europe.

After approval of abstracts, final papers will be due 15 February 2011 and should be submitted to *Feminist Economics* through the website (<http://mc.manuscriptcentral.com/rfec>). - **Call for Papers: Feminist Security Studies at ISA 2011**

As many of you know, Feminist Security Studies scholarship has proliferated in recent years raising important questions and critiques about the implications of global governance structures and institutions on women's rights and gender equality, particular in areas of armed conflict and violent transition around the world. Given the growing significance of Feminist Security Studies in International Relations, they plan two roundtables as well as a series of themed panels for ISA 2011 (though they also welcome papers beyond these themes).

Roundtable 1: Feminist Perspectives on Global Governance in the Area of International Peace and Security. For this roundtable, they envision a mix of feminist scholars and practitioners reflecting on the practices and processes of those international actors in the business of promoting, protecting and maintaining international peace and security.

Roundtable 2: The WomensStats Project and its Implications for Feminist Security Studies. The purpose of this roundtable is to continue the discussions of the 2010 ISA Working Group which focused on delineating and developing the FSS subfield. Using the work by Hudson, Caprioli et al. (e.g., "The Heart of the Matter" International Security 2009) and its reception by the field of security studies and the policy world as a launch pad, the roundtable outlines what this body of scholarship is doing, how we might build on its success, and how we can push the conversation to also include broader feminist insights that might not be quantifiable in quite the same way.

IRQR requests your assistance on a very urgent case involving Mahtab, an Iranian transsexual, and her husband, Saleh. It is no secret that queer Iranians who flee to Turkey and other countries continue to face risks due to homophobia. This often results in depression and post traumatic stress symptoms. Mahtab and Saleh, fled Iran to Turkey in June 2007, but have still not received refugee status. The common complications that queer refugees experience are escalated for them because their file has been rejected by office of the United Nations High Commissioner for Refugees in Ankara. Immediate attention by UNHCR is critical! Please show your support by writing to the UNHCR to urge them to reconsider their case and grant them international protection because their life is depending upon to the UNHCR's decision.
