1. GADN News

UN Women's Agency Working Group – Success!

Ahead of the G8 summit, which starts tomorrow (25th June), GADN's Working Group on the UN Women's Agency wrote to Prime Minister David Cameron to ask him to use his influence with the G8 and other UN member states to press for an ambitious agenda for the Women's Agency. The working group are troubled by the lack of consensus on the executive board and believe the creation of the Agency is a momentous opportunity to change the course of women's lives globally, at a time when they bear the brunt of disease and poverty. Because of the working group's letter, David Cameron has promised to raise the Women's Agency at the G8.

May Members Meeting

At the end of May, GADN held a joint network meeting with the Sexual and Reproductive Health and Rights (SRHR) Network. The meeting was well attended and presentations were given by Jessica Woodroffe (GADN), Leo Bryant (UK SRHR Network, Marie Stopes International) Mette Kjaerby (APPG for Population, Development and Reproductive Health), Karen Newman (Population and Sustainability Network) and zohra moosa (ActionAid UK). The speakers looked at family planning under the new coalition government, the changing landscape within parliament, the links between sexual and reproductive health and climate change, and SRHR from a feminist perspective. Plans were formulated for collaboration between the two networks and GADN looks forward to working closely with the SRHR Network over the coming months.

- **CAWN**, along with the Heinrich Boll Foundation, has published a report titled '**Femicide: A Global Phenomenon. From Lima to Madrid**'. The report seeks to provide an up-to-date regional perspective on the situation of femicide in Latin America. Women activists, human rights defenders, academics and civil society representatives from Mexico, Guatemala, Honduras, El Salvador, Chile, Peru, Bolivia and Colombia have written these articles to share their struggles in tackling femicide in their countries. It is currently only available in Spanish.
- **Oxfam** has released a new report titled '**The Global Economic Crisis and Developing Countries**'. The report reveals the depth and complexity of the impacts of the global economic crisis, and the vulnerabilities and resilience of poor people and countries worldwide.
- **Plan UK** has released a publication called '**Too Often in Silence**' on corporal punishment, sexual violence and bullying in relation to school-based violence in West and Central Africa.

- **Calls for Consultation: Focused Consultation on a Strategic Action Plan for the Sustainability of Violence Against Women and Girls Third Sector**
This Strategic Action Plan has been developed by Government Equalities Office (GEO) with the support of other government departments to look at what the Government could be doing to support the sustainability of the violence against women and girls (VAWG) third sector. We have consulted with government departments involved and are keen to gather views from the VAWG third sector, commissioners and others with an interest in the work. The Women's National Commission, which successfully raised the need to address the sustainability of the third sector with government, has agreed to manage this consultation on GEO's behalf. The consultation period will run from **Thursday 01 April to Friday 23 July 2010**.

At this very moment, Governments are negotiating about the creation of a new strong United Nations agency for women's rights. We must act now to ensure that this new agency will be created without delay and that it can really make a difference to women's lives all around the world! - **Campaign: Embrace Dignity Campaign- Stop Sex Trafficking and Prostitution of Women! 2010 WORLD CUP**

Large sporting events are known to increase levels of sex trafficking of women and girls and, from research conducted with our partners, we believe this year's World Cup will have similar results. The United Nations estimates that some 80% of persons are trafficked for sexual exploitation and that the majority are women and children. South Africa is a destination for trafficking. One trafficked woman or child is one too many. South Africa's constitution promotes human rights, human dignity, gender equality, women's rights and children's rights. Yet social, economic, racial and gender inequality persists. High levels of poverty among women exist in South Africa and neighbouring countries, making them vulnerable to sex trafficking and sexual exploitation.

The Embrace Dignity Campaign is a South African-based project of the Coalition Against Trafficking in Women - South Africa. The Embrace Dignity Signature Campaign has drawn up a petition to raise public awareness and invite all South Africans and our visitors to sign this petition and return it to us. We will hand the petitions to Parliament for action during the World Cup and when they consider the bills on trafficking and adult prostitution. - **Call for Translations: Structures of Violence: Defining the Intersections of Militarism and Violence Against Women**

This year marks the 20th **16 Days of Activism Against Gender Violence Campaign**, and with this important landmark, the Centre for Women's Global Leadership (CWGL) is considering new ways to utilize the campaign for transformative change. Year after year, new partners join the 16 Days Campaign to bring local, national, and global attention to the various forms of violence that women face. The attention that gender-based violence has received in international forums is a testimony to the powerful actions of women's rights activists around the world. Yet, despite this increased awareness, women continue to experience violations in alarming numbers and new forms of violence are emerging. We, as defenders of women's human rights, have a responsibility to look more closely at the structures in place that permit gender-based violence to exist and persist. After much consultation with activists, organizations, and experts from around the world, militarism has emerged as one of the key structures that perpetuate violence.

The **Theme Announcement** is available in English, Spanish, and French, however CWGL relies on volunteers to help with additional translation of campaign materials each year. - **Call for Proposals: 2010 Funding for Global Programs to Prevent & Respond to Gender-Based Violence--Refugee and Conflict Populations**

FY 2010 Funding Opportunity Announcement for global programs to better prevent and respond to gender-based violence (GBV) in refugee and conflict-affected populations, focusing on capacity-building, research and assessments to strengthen GBV prevention and response interventions among PRM populations of concern. Proposals should aim to strengthen the broader international community's response rather than building the capacity of a specific or single organization. Proposals for GBV prevention and response programs in specific locations should be submitted through the appropriate regional

and/or country specific funding opportunity announcement rather than through this announcement.

Applicants must clearly show how their planned projects will benefit PRM's primary target populations. The PRM is seeking to support:

a) Global projects which seek to build the capacity of NGO and implementing partners to prevent and respond to GBV, including Sexual Exploitation and Abuse (SEA). PRM will consider proposals that provide assistance to refugees, returnees, and internally displaced persons (IDPs) in Colombia and the North Caucasus. In all other regions, at least 50% of beneficiaries should be refugees or refugee returnees.

b) Projects involving research, assessments, or formative evaluations that could inform and strengthen PRM policy and programming for GBV prevention and response among PRM populations of concern per the mandates of the UN High Commissioner for Refugees (UNHCR) and the International Committee of the Red Cross (ICRC). PRM will prioritize proposals that focus largely on refugees and refugee returnees.

In FY2010, PRM anticipates providing \$1.4 million for global programs to prevent and respond to GBV in refugee and conflict-affected populations, including research and assessments to strengthen GBV prevention and response interventions among populations of concern. Individual proposals may not exceed \$300,000 in PRM-requested funding. As stated in the FY 2010 General PRM NGO Guidelines, PRM looks favourably on cost-sharing efforts and seeks to support projects with a diverse donor base and/or resources from the submitting organization.
